#### APPLICATION PROCESS:

- The EARLY BIRD fee for a 12' x 12' booth space is \$50 if application is submitted <u>PRIOR</u> to March 1<sup>st</sup>. From March 1<sup>st</sup> until the deadline of April 24th, the booth fee is \$60 for a 12' x 12' space. This fee covers all 3 days. Saturday attendance is MANDATORY from 10am-5pm, as we want our event to remain full during the peak of the festival to ensure a successful event for ALL vendors.
- There is no electricity on-site.
- Check or money order is to be made out to: Montello Area Chamber of Commerce or MACC. Booth fees are <u>NON-REFUNDABLE</u>.

- Applications must physically be in our PO Box no later than April 24<sup>th</sup>, 2025. This is <u>IMPERATIVE</u>, as the organizer for the Vendor Fair does not have access to the PO Box. Any applications delivered after this date may not be received in a timely manner, therefore may not be approved.
- All spaces are located outdoors. There will be no fee refund due to inclement weather. Each vendor is responsible for protecting their inventory from the elements.
- Spaces are not guaranteed, so please get your application turned in ASAP. If all spaces are full, you will be contacted and placed on the waiting list in the order your application is received. Your check or money order will not be processed unless you are accepted for a space.
- Collecting 5.5% Wi sales tax is the responsibility of the vendor.

#### SET-UP AND DISPLAY:

- Booth spaces are located on Park St (back side of the waterfall and across from Cty Rd Y).
- You will be contacted approximately 1 week prior to our event with important information, including your site number. Sites will be marked with spray paint on grass upon arrival.
- Vendor vehicles must be parked off-site this year; NO VEHICLES WILL BE ALLOWED AT YOUR SITE. We will have designated vendor parking; more info will be provided closer to the event.
- All tables must be neatly and appropriately covered with a tablecloth that hides storage boxes so they cannot be seen by the public.
- There will be 2 porta potties on-site.
- Please do not leave garbage behind during or after the festival. We ask that all garbage is removed each day, as there are limited garbage cans available, and they will only be collected after the event is over with.

#### TERMS:

- No live animal sales.
- Merchandise deemed profane is not allowed.
- Camping/sleeping in vehicles overnight is not permitted at this event.
- Troublesome vendors may be removed without a refund.
